- (e) To answer and account to the Council and the community for the delivery of services and the performance of the Council; and
- (f) To challenge the performance of the Council in order to achieve relevance and efficiency.

- (h) To keep the Council informed of proposals for changes in practice and procedure
- (i) To provide political leadership and guidance to Officers in any emergency situation and report such guidance to the next meeting of the Executive Committee.

15 – Review of the Representation of Political Groups on Committees

The Chief Executive reported that Section 15 of the Local Government and Housing Act 1989 placed a duty on the Local Authority at its Annual Meeting (or as soon as practicable after the meeting) to review the representation of the different Political Groups on the Council. In performing this function, the Council was required to determine the allocation to different political groups of the seats which fell to be filled by appointments and in making such determinations to give effect, so far as reasonably practicable, to the following principles:-

- 1. That not all the seats on the body be allocated to the same political group.
- 2. That the majority of the seats on the body be allocated to a particular political group if the number of Members belonging to that group is a majority of the Authority's membership.
- 3. Subject to numbers (1) and (2) above, that the number of seats on the ordinary Committees of the Authority which were allocated to each political group bears the same proportion to the total of all seats on the ordinary Committees of that Authority as is borne by the number of Members of that group to the membership of the Authority.
- 4. Subject to numbers (1) and (3) above, that the number of seats on the body which are allocated to each political group bears the same proportion to the number of all the seats on that body as is borne by the number of Members of the group to the membership of the Authority.

The number of seats held on the Council by each group was:-

Labour Group - 29 Conservative Group - 7

The relevant Regulations required that, so far as was reasonable, the proportion of the total seats on Committees and on individual Committees held by the Political Groups bear the same proportion to their seats on the Council.

The Chief Executive submitted as an appendix to his report, the recommended allocation of seats on Committees and Sub-Committees and requested Members to note the following:-

- 1. The Local Government Act 2000 (Section 53 (10)) provided that the Standards Committee was not regarded as a body to which the duty to allocate seats to political groups applied. Hitherto, five Members had been appointed in addition to the Independent Chairman and two other Independent Members. Those five seats had nevertheless been split on a proportional basis in the past.
- 2. The number of seats on the Executive, Licensing, Planning and Overview and Scrutiny Committees had been set at twelve.

- 3. The Council's Constitution provided that:-
 - (a) Members of the Executive Committee would not be eligible to be Members of the Planning Committee and vice-versa.
 - (b) One Executive Committee Member from each political group may be appointed to the Overview and Scrutiny Committee subject to the proportionality rules. All other Councillors qualified to sit on the Committees and any Sub-Committees established.
- 4. The number of Councillors on the Housing Management Forum had been set at 8.
- 5. The number of Councillors on the Audit Committee has been set at 6.
- 6. The number of Councillors on the Grants Sub-Committee had been set at 9.

The recommended seat allocations in respect of those Outside Bodies to which the proportionality rules had been applied and in respect of Forums, Working Groups and Panels had been attached as an appendix to the Chief Executive's report.

It had been recommended that the Council delegated to Committees the power to make appointments to Outside Bodies etc. appropriate to their terms of reference.

It was moved by Councillor Pidduck and seconded by Councillor Garnett, and RESOLVED:-

Foreword

In October 2010 it was agreed that the Corporate Services Committee and the Regeneration and Community Services Committee would merge and operate as a Joint Committee for the remainder of the year.

In 2011/12 only one Committee was appointed called the Overview and Scrutiny Committee. The responsibility for monitoring the Council's risk management and performance management arrangements has been transferred to the Audit Committee in line with recognised good practice.

Corporate Services

Chair, Corporate Services Scrutiny: Councillor Tony Callister

In 2010/11 this Committee had focused on equalities performance and monitoring of progress on the recommendations of the Legionella Sub-Committee.

Equalities Performance

Monitoring of the Council's work towards the Achieving Level of the Equalities Framework for Local Government was carried out by the Committee.

In December 2010 the Council was assessed as Achieving against the equalities framework.
