14 – South Lakes Wild Animal Park Ltd – Zoo Licensing Act 1981 (as amended) Special Inspection carried out on 28th/29th January, 2014

The Environmental Health Manager submitted a report detailing the findings of a Special Inspection carried out at South Lakes Wild Animal Park Ltd carried out under the provisions of Section 11 of the Zoo Licensing Act 1981 (as amended). The inspection report made recommendations for modifications to the Zoo Licence and also proposed adding 18 new Conditions and removing some existing Conditions. The report had also recommended that two Direction Orders be served on South Lakes Wild Animal Park due to continued non-compliance with existing conditions on the Zoo Licence.

The Conditions and the two Direction Orders outlined in the Environmental Health Manager's report had been discussed in detail and each of the parties concerned had been given the opportunity to make representations and ask questions. The Chairman had announced at the beginning of the meeting that the Committee would deal with the 18 Conditions in three blocks of six and then the two Direction Orders would be considered at the end of the meeting. During the course of the meeting, at relevant points, all parties with the exception of the Committee Members, Paul O'Donnell (Solicitor), Keely Fisher (Democratic Services) and Paula Westwood (Democratic Services), withdrew and were re-admitted to the meeting following the Committee's deliberations.

Committee Members had heard all representations and asked questions in respect of the 18 Conditions and the two Direction Orders. The Committee had made preliminary decisions in respect of the 18 Conditions but had not deliberated on the two Direction Orders.

The meeting was adjourned at 7:07 p.m.

- (v) That existing Condition 16 be removed as it would be addressed under health and safety legislation;
- (vi) That existing Condition 17 be removed as it had been replaced with a new Conditions 12 and 13 (as above);
- (vii) That existing Condition 18 be removed from the Licence;
- (viii) That existing Condition 19 be retained on the Licence;
- (ix) That existing Condition 20 be removed from the Licence and replaced with new Conditions 6 and 7 (as combined above);
- (x) That existing Condition 21 be removed from the Licence as South Lakes Wild Animal Park had complied with this condition;
- (xi) That existing Condition 22 be retained on the Licence;
- (xii) That existing Condition 23 be retained on the Licence;
- (xiii) That existing Condition 24 be retained on the Licence; and
- (xiv) That existing Condition 25 be retained on the Licence.

20 – Application for Street Collection Permit – The Royal British Legion

The Senior Environmental Health Officer (Licensing) reported that he had received an application from Mr R. D. Sheppard of the Royal British Legion in respect of a Street Collection Permit from Saturday 31st October, 2015 to Saturday 7th November, 2015.

The Senior Environmental Health Officer (Licensing) advised Members that the current policy was that charitable organisations be granted a permit for one day only each year. He had therefore recommended in his report that the application be approved for a collection on Saturday 7th November 2015 only.

It was moved by Councillor Derbyshire and seconded by Councillor Pemberton that an application for a Street Collection Permit be approved for seven consecutive days in October/November 2015. A vote was taken and the results were 4 for and 5 against. The vote was therefore declared lost.

21 - Application for a Caravan Site Licence - Caravan Sites and Control of Development Act 1968 - The Allotment, John Street, Askam-in-Furness

The application was to licence the site for two caravans and one storage unit. A site plan had been received and was appended to the report. The units would be sited with appropriate separation distances as required by the Model Standards 2008 for Caravan Sites in England.
