#### 34 - Street Trading Application - Taylors (Cumbria) Amusements

The Senior Environmental Health Officer (Licensing) reported that he had received an application for a Street Trading Consent from Mr O. Taylor of Taylors (Cumbria)

Amusements to site the following amusements on Dalton Road near to Portland Walk or another site within the Town Centre area on the date of the Christmas lights switch on:-

- 1) Kiosk 14'x 6' fun sweets selling only novelty sweets, candy floss and hot and cold drinks;
- 2) Side stall 8' x 4' fairground prize game; and
- 3) 2 x kiddie's carousels 14' diameter.

He reported that similar applications had been approved in the past subject to no adverse comments being received from consultees and subject to the attractions being sited in a position which was to their satisfaction.

A copy of the letter of application had been appended to the report and he advised that to date he had not received any comments from consultees.

RESOLVED:- To approve the application for Street Trading Consent subject to no adverse comments being received from consultees.

#### 12 - Minutes

The Minutes of the meetings held on 22nd August and 12th November, 2013 were taken as read and confirmed.

### 13 - Application for Temporary Event for Bar Continental, Abbey Road, Barrow-in-Furness

The Senior Environmental Health Officer (Licensing) submitted a report concerning an application made by Mr Craig Armes for a Temporary Event at Bar Continental, Abbey Road, Barrow-in-Furness. The Temporary Event application was to relax a condition on the current licence to allow use of the outside area/beer garden between the hours of 23:00 and 01:00 on Saturday 14th June, 2014 which was the first of England's matches at the 2014 Football World Cup.

The Senior Environmental Health Officer informed the Sub-Committee that a representation had been received from Cumbria Constabulary; a copy of which had been appended to the report.

Included within the report was reference to Paragraphs of national guidance issued under Section 182 of the Licensing Act 2003 which were particularly relevant for Members when making a decision concerning this application. Reference had also been made to Paragraphs of the Council's current Statement of Licensing Policy to assist Members in their decision making.

The application had been copied to the relevant responsible Authorities and had also been advertised as required by statute for a 28 day period. A copy of the application together with a copy of the plan showing the location of the premises had been appended to the report.

It was noted that the Condition relating to the outside area/beer garden had been placed on the Licence in 2005 following a Sub-Committee hearing held to determine the original application. The Licensing Sub-Committee report and representations from that meeting back on 29th September, 2005 had been appended to the report for Members' information.

The applicant, Mr Armes and his representative attended the meeting and addressed the Sub-Committee and answered questions by Members. Representatives from Cumbria Constabulary also addressed the Sub-Committee and answered questions by Members and the applicant.

The applicant advised the Sub-Committee that if noise issues were the main concern from the Police then he would be happy to refrain from screening the match in the outside area/beer garden, however there would still be requirement for that area to be used for smoking and toilet facilities. It was noted that the applicant had installed six portaloos in the outside area/beer garden and one urinal within the premises to cater for the large numbers who may attend the premises.

Police Community Sergeant John McIntosh informed the Sub-Committee that the residents of nearby Hawke Street had been canvassed regarding the application for the Temporary Event Notice which resulted in mixed views from residents, however a number of residents had been satisfied with the application as it was a one-off event. On behalf of the Police, Sergeant McIntosh requested that should the Sub-Committee agree to relax the Condition on the current Licence to allow the use of the outside area/beer garden between the hours of 23:00 and 01:00 on Saturday 14th June that the following conditions be imposed:-

- The provision of six portaloos in the outside area/beer garden and one urinal within the premises;
- That four door staff be present on that date (two at the front of the premises and two at the rear of the premises);
- That plastic glasses only be used in the outside area/beer garden; and
- That a Dispersal Policy be produced to ensure people would leave the premises in a safe manner at the end of the night.

RESOLVED:- That in accordance with Section 100A(4) of the Local Government Act 1972 and Access to Information (Variation) Order 2006, members of the public (including the press) be excluded from the meeting during the deliberations of the Sub-Committee, on the grounds that it involved the likely disclosure of exempt information as defined in Paragraph 6 of Part One of Schedule 12A of the said Act.

## The public along with the Police withdrew and were re-admitted to the meeting following the Sub-Committee's deliberations.

RESOLVED:- The Sub-Committee unanimously agreed to grant the application for a Temporary Event at Bar Continental, Abbey Road, Barrow-in-Furness which allowed the relaxation of the Condition on the current Licence to allow the use of the outside area/beer garden between the hours of 23:00 and 01:00 on Saturday 14th June, 2014 which the first of England's matches at the 2014 World Cup subject to the following conditions being imposed:-

- 1. The provision of six portaloos in the outside area/beer garden and one urinal within the premises;
- 2. That four door staff be present on that date (two at the front of the premises and two at the rear of the premises);
- 3. That plastic glasses only be used in the outside area/beer garden; and
- 4. That a Dispersal Policy be produced to ensure people would leave the premises in a safe manner at the end of the night.

The Sub-Committee arrived at their decision having regard to the national guidance issued under Section 182 of the Licensing Act 2003 and the Council's current Statement of Licensing Policy relating to the prevention of crime and disorder. In addition the decision had been based on demonstrable good management of the premises in the past by the current Premises Manager. It was also noted that no objections had been received from the Council's Environmental Protection Team.

The Chairman advised that the Licensing Authority would write to all parties confirming the decision within 5 working days. He added that if any party was aggrieved by the decision then they had the right of appeal to the Magistrates Court within 21 days of the decision being made.

## 4 - Application for Review of Premises Licence under Licensing Act 2003 - Istanbul, 49 Crellin Street, Barrow-in-Furness

The Senior Environmental Health Officer (Licensing) reported on an application he had received from Cumbria Constabulary for a Review of the Premises Licence (PL 0306) of the Istanbul, 49 Crellin Street, Barrow-in-Furness.

The application for the review related to the following licensing objectives:-

- 1) The prevention of Crime and Disorder; and
- 2) The protection of Children from Harm.

The grounds for the review were detailed in a copy of the application which was attached as an appendix to the report.

A copy of the licence which detailed permitted licensable activities and conditions was also attached as an appendix to the report.

The application had been copied to the relevant Responsible Authorities and had been advertised as required by statute for a 28 day period.

Included within the report was reference to Paragraphs of National Guidance issued under Section 182 of the Licensing Act 2003 (revised June 2014) which were particularly relevant for Members when making a decision concerning this application. Reference had also been made to Paragraphs of the Council's current Statement of Licensing Policy to assist Members in their decision making.

A representative from Cumbria Constabulary addressed the Sub-Committee and answered questions by Members.

The applicant had been invited to attend to make representations but had failed to do so.

RESOLVED:- That in accordance with Section 100A(4) of the Local Government Act 1972 and Access to Information (Variation) Order 2006, members of the public (including the press) be excluded from the meeting during the deliberations of the Sub-Committee, on the grounds that it involved the likely disclosure of exempt information as defined in Paragraph 6 of Part One of Schedule 12A of the said Act.

Environmental Health Officers along with the Police withdrew and were readmitted to the meeting following the Sub-Committee's deliberations.

RESOLVED:- That the Premises Licence be modified to remove all conditions relating to the sale of alcohol.

The Sub-Committee arrived at their decision having considered the National Licensing Guidance and hearing representations. The decision was made after taking into account the Council's Statement of Licensing Policy and was thought necessary to promote the Licensing Objectives relating to the prevention of crime and disorder and the protection of children from harm.

The Chairman advised that the Licensing Authority would write to all parties confirming the decision within 5 working days. He added that if any party was aggrieved by the decision then they had the right of appeal to the Magistrates Court within 21 days of the decision being made.

Title: Hackney Carriages – Unmet Demand Survey

#### **Summary and Conclusions:**

This report informs members of the need for a review of the number of Hackney Carriage Licences issued and seeks agreement to consult licence holders on their views.

#### **Recommendation:**

That Members determine a course of action in this case.

#### Report

Members will be aware that the Borough Council has a quantity control policy which limits the number of Hackney Carriage licence issued which is currently 145.

In 2003 the Office of Fair Trading published a market study which challenged the issue of quantity control policies in relation to hackney carriage licences and advocated that market forces should dictate demand. As a result, any licensing authorities that wish to continue operating a quantity control policy must carry out an "unmet demand" survey every three years and review their policy.

Three "unmet demand" surveys have been carried out since then and the results of the last one were considered by Members at a meeting in April, 2009 and it was agreed not to change the policy as there was no current unmet demand demonstrated.

It is almost three years since the last survey took place and a review of the policy is now due. I would therefore, ask Members to agree to gauge the views of Hackney Carriage licence holders in respect of the following as a preliminary to undertaking the Unmet Demand Survey:-

- Do they want the quantity control policy to remain.
   A number of local authorities have relaxed their policies and it is generally the trade that wish to retain a quantity control policy; and
- 2) If so, would they be prepared to fund the "Unmet Demand Survey"

  On the two previous occasions that unmet Demand surveys have been undertaken Hackney Carriage licence holders have paid for the survey

- through an increase in the appropriate licence fee for one year to cover the cost
- 3) Would they be agreeable to a relaxation of the policy in very specific circumstances to enhance the quality and variety of Hackney Carriages available to the public e.g. Any 'new' licences issued were for specific vehicles which were, for example, wheelchair accessible from the pavement.

Equalities legislation has suggested that licensing authorities are likely to be told what percentage of the Hackney Carriage fleet must be wheelchair accessible. In the meantime Officers will investigate the current costs of carrying out an Unmet Demand Survey and furnish Members with a comprehensive response from the taxi trade at a future meeting.

Title: Vehicle Testing Stations

#### **Summary and Conclusions:**

This report deals with the provision of the licensed vehicle testing service provided on behalf of the Council by local MOT testing stations.

#### Recommendation:

That I be authorised in consultation with the Chairman and Vice Chairman of the Committee to award contracts for the provision of licensed vehicle testing to any or all of the interested parties subject to them meeting the Borough Council's criteria for a vehicle testing station for a period of 3 years effective from 1st January 2015.

#### <u>Report</u>

An advertisement has been placed in the local newspaper inviting garage proprietors to submit tenders for the provision of a vehicle testing service for the Borough Council in respect of its taxi licensing function. Testing stations must be capable of carrying out full tests on both petrol and diesel engine vehicles and have at least two qualified testers to ensure cover during periods of holiday and illness.

The current arrangements for the service are due for renewal on 1st January, 2015 and I would ask Committee to delegate the assessment of any submissions received as a result of the advertisement to me in consultation with the Chairman and Vice-Chairman for awarding contracts for a period of 3 years effective from that date.

Part One

Title: Application for the removal of conditions from a Caravan Site Licence – Caravan Sites and Control of Development Act 1968 – Old Candleworks Caravan Park, Old Candleworks Road, Barrow in Furness

#### **Summary and Conclusions:**

This report deals with an application to remove unnecessary conditions from an existing Caravan Site Licence.

#### Recommendation:

That Members approve the application

#### Report

Following a recent inspection of the Old Candleworks Caravan Park, Old Candleworks Road, Barrow in Furness by Jen Curtis, Senior Licensing Officer a number of conditions placed upon the licence were found to be unnecessary and as such should be removed from the licence.

The conditions to be removed are:

- 1. For caravans without their own water supply and water closets, communal toilet blocks must be provided with the following facilities:
- 2. Male: 4WCs, 3 Urinals, 3 Wash Hand Basins, 2 Showers
  - a. Ladies: 4WCs, 3 Wash Hand Basins, 2 Showers
- 3. The wash hand basins and showers must have adequate supplies of hot and cold water available.
- 4. The toilet blocks shall be kept in a clean and tidy condition, and the amenities therein maintained in good working order.
- 5. All pitches must be separated using fencing as shown on the plans.
